Minutes of meeting from the Public hearing event in the Ministry of Labor and Social Policy on the "Stakeholder Engagement Plan", "Labor Management Procedure", "Environmental and Social Commitment Plan", for the Social Insurance and Pension Administration Project

Skopje (14.11.2019)

On the 14.11.2019 at 11:00 o'clock at the premises of the Ministry of Labor and Social Policy, public hearing event on the draft "Stakeholder Engagement Plan", "Labor Management Procedure" and "Environmental and Social Commitment Plan" within the Social Insurance and Pension Administration Project.

In Annex 1 is disclosed the Announcement for holding a public hearing on the draft documents published on the website of the draft " Stakeholder Engagement Plan", " Labor Management Procedure" and " Environmental and Social Commitment Plan" within the Social Insurance and Pension Administration Project.

Public hearing event was attended by 15 persons from different stakeholder groups (MLSP, World Bank, Association of the Blind, National Association of Disabled People of the Republic of Macedonia, Mobility Macedonia, Association of Protective Societies of Macedonia - ZAPOVIM). The list of attendees is shown in Annex 1.

Mrs. Elena Trpkovska, from Project Implementation Unit in Ministry of Labor and Social Policy, opened the public debate on the draft documents and briefly presented the Social Insurance and Pension Administration Project.

The project consists of three components: Component 1: Improving the Quality of Social Security Administration Services; Component 2: Strengthen the regulatory framework for people with disabilities and dangerous occupations. Component 2.1: Establishment of a Unified Disability Assessment System and a Central Disability Assessment Coordination Body; Component 2.2: Reforming the Employment System for Persons with Disabilities; Component 2.3: Revision of the List of Dangerous Occupations; Component 3: Project Management, Monitoring and Evaluation.

All project activities will be financed by a loan from the World Bank through the Government of the RNM. The project will be implemented by the MLSP of the RNM as the main responsible institution and key agency in cooperation with PDIF, HIF, EARM and IRS. The MLSP Project Implementation Unit will have overall responsibility for project implementation, project coordination, monitoring activities and reporting.

Following a brief introduction to the Project, Mrs. Tanja Nikolovska presented the main findings of the documents prepared under the Social Insurance and Pension Administration Project (SIPA): Stakeholder Engagement Plan (SEP) (informs how stakeholders will be involved throughout the project, what were the previous activities under the SIPA project and an

overview of the responsibilities of the relevant institutions and contractors in the implementation of future activities);

Labor Management Procedure (LMP) (describes the type of staff to be hired by the project and its management); and an Environmental and Social Commitment Plan (ESCP) that outlines measures and activities to comply with the provisions set out in the Stakeholder Engagement Plan (SEP), as well as other instruments that will be or are already prepared for the needs of the Project, Labor Management Procedure (LMP).

After the presentation of the goals and the meaning of the draft documents, the discussion was opened.

After the presentation of the three documents, the participants expressed their satisfaction with the launch of the Project and their involvement in the project activities.

Mrs. Jahona Ramadani of the MLSP mentioned that all draft documents "Stakeholder Engagement Plan", "Labor Management Procedure" and "Environmental and Social Commitment Plan" are available on the MLSP website and anyone can comment, or send suggestion regarding them.

Mr. Zoran Anusic from the World Bank, emphasized that stakeholders have been involved since the very beginning of the project, which is very important, as well as the cooperation between the institutions involved in the Project.

Mr. Branimir Jovanovski from Mobility Macedonia, emphasized that their Union has more than 200 members, they are interested in all planned reforms with the Project and expect their members to be adequately trained (educated) in the future in order to be properly employed. Jovanovski, asked for information on whether the establishment of a Unified Disability Assessment System will be centralized in Skopje or dispersed as many disabled people would not be able to come to Skopje.

Mrs. Ramadani explained that the project is still in its infancy, the system has not been designed, but a body will be set up to coordinate all disability claims. The aim is to simplify the procedure for determining disability and assessing the ability to work is planned by one Commission.

Mr. Dusan Tomsic from the Ministry of Labor and Social Policy, mentioned that in addition to medical disabilities, the functional capacity of people with disabilities will need to be established.

Mr. Anushic confirmed that the aim was to unify the methodology to facilitate evaluation. He cited an example of organizing regional forensics in a city that would bring all the people living in the vicinity to simplify the process.

Mr. Tomsic mentioned that the project is expected to intensify next year (April - May 2020), when a new draft of the Law on Pension and Disability Insurance is expected to include rehabilitation as well.

Mr. Vlado Dodevski from the Association for Protection Societies of Macedonia (ZAPOVIM) which has 2700 members (45% of whom are mentally retarded), emphasized that it is necessary to use the existing resources in the country especially in the field of psychosocial inclusion to save money and simplify the process. He mentioned that it is very important to train people with disabilities depending on their desire and the situation on the labor market.

Mrs. Trpkovska added that the stakeholder meetings will continue to be implemented and expect intensification of project activities in spring 2020.

The participants did not have any comments regarding the prepared draft documents under the SIPA Project. After exhausting all comments, Mrs. Trpkovska closed the public debate.
